- We invest based on risk tolerance, investment objectives, liquidity constraints and timeline.
- Our model portfolios are designed by BlackRock’s Model Portfolio Solutions and managed by Banorte Asset Management in partnership with BCP Global. The purpose of these model portfolios is to deliver efficiency, transparency, and cost effectiveness to our clients through the digital platform.
- The selected UCITS ETFs that are part of the Model Portfolios are designed to meet specific goals such as global diversification, tactical exposures, and tax efficiency for Mexican residents.
- The implementation procedure guides each individual investors on how to invest in the most appropriate portfolio according to their risk profile and investment goals.
- BlackRock’s portfolio construction process:
 - Variables: The variables in the systematic optimization process are Return-Risk-Efficiency.

Pricing and Sign-up

- Steps to open an account:
 1. Establish your profile by answering a few questions to determine your risk tolerance, investment objectives and time horizon and receive personalized portfolio recommendations
 2. Create your account
 3. Your money is invested in your globally diversified portfolio.
 4. Your portfolio is managed constantly and adjusted as needed to optimize returns for the intended level of risk.
- There are no trading, rebalancing, or changing portfolios fees.
- Simple annual fees are:
 - \$50,000 to \$100,000 = 1.85% per year
 - \$100,001 to \$200,000 = 1.75% per year
 - \$200,001 to \$300,000 = 1.50% per year
 - \$300,001 to \$1 million = 1.25% per year
 - \$1 million and higher = 1% per year
